1. Background

Under section 20 of the Fair Access to Regulated Professions and Compulsory Trades Act, 2006 (FARPACTA), which is substantially similar to section 22.7(1) of Schedule 2 of the Regulated Health Professions Act, 1991 (RHPA),

"A regulated profession shall prepare a fair registration practices report annually or at such other times as the Fairness Commissioner may specify or at such times as may be specified in the regulations".

Section 23 of FARPACTA and Section 22.9 of Schedule 2 of the RHPA then go on to indicate that the Fairness Commissioner shall specify the form in which these reports shall be prepared, along with the required filing dates. This section also stipulates that a regulator must make these reports public.

It is pursuant to these authorities that the Office of the Fairness Commissioner (OFC) has required that each regulator complete its 2023 Fair Registration Practices Report (FRP).

Please note that this report covers the time-period from January 1 to December 31, 2023.

The FRP:

- Collects information about the organization, applicants to the profession and current membership.
- Provides information to the public about how the organization has implemented fair registration practices during the reporting period.
- Helps the OFC to successfully undertake the education and compliance activities which include monitoring, applying a risk-informed compliance framework, assessing performance, and sharing best practices.
- Determines whether the regulator is complying with recently enacted legislative and regulatory provisions designed to reduce barriers for domestic labour mobility and internationally trained applicants.
- Identifies trends across regulated professions and regulated health colleges.

Please note that the 2023 version of the FRP has changed from the previous version in terms of both form and content as the OFC's enabling statutes have evolved and as the office migrates to a more permanent portal-enabled database solution.

Licensing requirements (brief description for each requirement listed):

Academic requirement	An applicant for registration must have graduated from an approved Canadian Respiratory Therapy program or have demonstrated through the CRTO's assessment process that they have the required entry-to-practice competencies.
Experience requirement	The CRTO does not have an experience requirement. However, applicants for registration must meet the currency requirement. That is,

	applicants for General and Graduate Certificates of Registration must have graduated from their Respiratory Therapy (RT) program within two years immediately preceding the application for registration unless the applicant was practicing Respiratory Therapy within those two years. Language requirement	An applicant for registration must be able to communicate effectively in English or French in a healthcare environment. Fair access legislation requires regulators to take reasonable measures to ensure that any third parties undertake assessment of qualifications in a way that is transparent, objective, impartial and fair.

College of RESPIRATORY THERAPISTS of Ontario takes the following measure(s) to ensure fair and timely assessments:

EQual/Accreditation - Canada's health education accreditation program assesses educational programs against standards developed by the Health Standards Organization (HSO). EQual provides accreditation services for 20 health profession education programs, including Respiratory Therapy. The program involves a six-stage accreditation process conducted over a six-year cycle. All Ontario RT educational programs, as well as most Canadian RT programs and one international RT program, are assessed and certified under the same Accreditation Canada standard. The National Alliance of Respiratory Therapy Regulatory Bodies (NARTRB), which the CRTO is a member of, has an agreement with EQual. The CRTO has a parallel Client Agreement with EQual that is reviewed and renewed annually by the Registrar. EQual holds quarterly meetings of all members, which provide an opportunity for dialogue on regulatory matters and policies, program insights and results, and program policy changes. Concerns regarding the fairness of the accreditation process can be brought forward to EQual by any of the educational facilities and/or EQual members. Also, the members can participate in accreditation surveys to share their knowledge. Health Professionals Testing Canada (HPTC) - The HPTC develops and conducts the national registration examination that the CRTO Council has approved. The HPTC exam is based on the most current National Competency Framework, which sets the examination weighting matrix. The CRTO has a Service Agreement with the HPTC that is reviewed and renewed annually. As part of this agreement, HPTC provides the CRTO with copies of all formal reports, analyses, studies, or other documentation regarding the examination's validation, reliability, scoring method, or other relevant characteristics. In the agreement, the HPTC agrees to

perform its obligations in a manner consistent with its privacy policy and per the principles of transparency, objectivity, impartiality and fairness.

5. Accomplishments, risks and mitigations

Key accomplishments and risks pertaining to fair registration practices during the reporting period are summarized below.

A. Accomplishments

- In 2023, the CRTO successfully addressed several significant regulatory changes, including those related to Registration Regulation, Controlled Acts Regulation, and Exemption Restricted Titles Regulation. Due to these changes, many of the CRTO's policies, procedural documents, webpages, and other materials were updated or developed. In addition, the CRTO conducted a thorough review of the Registration Regulation, with a focus on enhancing the efficiency of registration processes and ensuring alignment with other Respiratory Therapy jurisdictions. Proposed amendments to the regulation have been submitted to the Ministry of Health, and the CRTO is awaiting updates from the Ministry.
- 2 CRTO's 2021 2025 Strategic Direction (highly competent & effective Council): In March 2023, the CRTO enlisted the services of a third-party assessor to evaluate the effectiveness of the Council. This assessment was conducted to fulfill the obligation of a third-party assessment, as outlined in the College Performance Measurement Framework (CPMF). According to the assessor's feedback, the CRTO and its Council members have met the requirements outlined in the principles of good governance. These include: Providing orientation and training to Council members prior to their first Council meeting. Ensuring Council members understand a Conflict of Interest in the context of the Regulated Health Professions Act (RHPA) and the Council's operations. Consistently considering the public interest in all Council decisions. Maximizing transparency in the Council's decision-making processes. Deliberating in-camera matters only when confidentiality is mandated for legal purposes or privacy concerns. Implementing the principles of Right Touch Regulation in Council decision-making, prioritizing

regulatory resources on matters posing the greatest risk to public protection. The involvement of a third-party assessment ensures that Council members are competent in their decision-making process, including in registration-related decisions.

As part of the 2021 - 2025 Strategic Direction, the CRTO has initiated quarterly reporting on Key Performance Indicators (KPIs) for each program area to the Council. Specifically, in the Registration department, these KPIs play a crucial role in ensuring that the CRTO not only meets but also surpasses the processing timeline requirements mandated by the Registration Requirements Regulation. The reporting of the KPIs enhances accountability and transparency within the organization while facilitating continuous improvement in registration processes.

B. Risks and Mitigations

Mitigation Measure
e CRTO maintains all membership records d data in electronic form. To address tential risks such as IT infrastructure truptions, data integrity compromises, and authorized access to records (e.g., cybertacks), the CRTO has engaged the services a cybersecurity company (ISA). ISA inducted a comprehensive assessment of a CRTO's IT security architecture to identify linerabilities and provide recommendations remedial actions. The CRTO has begun plementing the recommended measures ensure the security of its data. Additionally, a CRTO has implemented a comprehensive off training program focused on persecurity to enhance awareness and exparedness. Aside from security changes, a CRTO is in the process of implementing a widatabase. There are potential risks to egrating a new database, such as slower

	the new system. The CRTO plans to mitigate this risk through comprehensive staff training and utilizing the resources provided by the vendor.
Unaccredited Ontario Programs	By December 2024, the CRTO will have a group of graduates from a new Ontario RT program that has not yet received accreditation through Accreditation Canada. Therefore, the CRTO may be in a situation where it is necessary to determine how to register a graduating class of RTs from an unaccredited educational program. Currently, the CRTO only approves programs that obtain and maintain accreditation status through Accreditation Canada. The current Registration Regulation does not permit the CRTO to assess students graduating from a Canadian program, if their program is not accredited. In 2023, the CRTO submitted proposed changes to its existing Registration Regulation that would enable the CRTO to assess students who may graduate from an unaccredited Canadian program. This would allow the CRTO to ensure that students graduating from an unaccredited domestic education program have the requisite entry-to-practice competencies necessary to safeguard the public. The CRTO has been in communication with the Ontario Ministry of Health regarding the above-mentioned situation and hopes to have a resolution by the end of this calendar year.
Clinical Skills Assessment Fees and the increased number of internationally educated healthcare professionals applying to register with the CRTO.	The CRTO was recently required to increase the Clinical Skills Assessment (CSA) fee for Internationally Educated Healthcare Professionals (IEHPs). This fee increase was due to the increased cost of booking the

appropriate simulation facility necessary to complete the CSA. Applicants are now required to pay the CSA fee of \$5,000 (previously the fee was \$4,250). This fee increase is out of the CRTO's control and may pose a risk of making the assessment process financially inaccessible to applicants. The fee increase, coupled with the increase in the number of IEHPs (including those from other jurisdictions, which the CRTO assesses on behalf of most other regulated RT jurisdictions in Canada) may be putting the CRTO at additional risk. This is because of the finite capacity and resources available to manage these applications. To mitigate these risks, the CRTO is looking at the possibility of utilizing other, potentially less costly simulation facilities to conduct the assessment. In addition, the CRTO may increase the number of staff to support the CRTO's Entry-to-Practice Competency Assessment program. https://www.crto.on.ca/pdf/Policies/Policy.RG-425.pdf

6. Changes to registration practices

During the January 1 to December 31, 2023 reporting period, College of RESPIRATORY THERAPISTS of Ontario has introduced the following changes impacting its registration processes. Changes, anticipated impacts, and risk mitigation are summarized below.

A. Registration requirements and practices

Registration process	Changes Made (Yes / No)	Description
Registration requirements either through regulation, by-law or policy	Yes	The CRTO drafted a new Vulnerable Sector Checks policy in 2023. The draft policy was posted for public consultation and then subsequently approved in March 2024. The policy will come into effect on September 1, 2024. As part of its public interest mandate, the CRTO must ensure that applicants' past and present conduct affords reasonable grounds for these belief that they will practice respiratory therapy with decency, integrity, honesty, and in accordance with the law. To this end, under the new policy, all applicants for registration will be required to submit the results of a Vulnerable Sector Check (VSC) as part of their application for registration with the CRTO. For more information, please see the VSC policy: https://crto.on.ca/pdf/Policies/Policy.RG-430.pdf. The CRTO anticipates that the VSC requirement will delay registration timelines. To mitigate the potential delays in processing applications, the CRTO staff is making changes to the application portal and reviewing its processes and procedures to ensure smooth implementation of the new requirement. In addition, to ensure that applicants are aware of the new requirement, CRTO staff developed a comprehensive communication plan, which includes updates to CRTO's website (e.g., a new FAQ webpage), visits to RT schools in Ontario, and updates to our guidance documents. The Ontario government introduced the "As of Right" rules in 2023. Out-of-province regulated RTs (inter-jurisdictional RTs) who meet specific conditions may start working in public Ontario

hospitals, long-term care homes, and the University of Ottawa Heart Institute without having to first register with the CRTO. Once the Exemption-Restricted Title Regulation came into place, the CRTO created a new webpage to communicate the new provision and updated various registration-related documents (guides, fact sheets, and forms) to outline this change. The Ontario Ministry of Health (MOH) also amended portions of O. Reg 596/94 (General -Part VIII – Registration) to enable the creation of an Emergency Class of Registration. The CRTO's Emergency Registration Policy was revised to align with these regulation amendments. Additionally, the CRTO drafted By-Law revisions to include the renewal and fee structure of the Emergency Registration Class (these By-law revisions were approved in March 2024. The Graduate Certificate of Registration Policy has been revised in 2023 to ensure that it is consistent with relevant legislation and existing registration practices. Specifically, the policy was updated to reflect the amendments under section 14 of the Controlled Acts Regulation (O. Reg. 107/96) pertaining to tracheostomy tube changes. Although these changes do not directly relate to the CRTO's registration requirements, they ensure that applicants for registration in the Graduate Class have a clear understanding of the conditions that will apply to their certificates of registration. The Application for Registration - File Closure Policy was revised in 2023 to ensure its alignment with legislation and existing registration practices. This revision was prompted by changes to legislation, specifically Ontario Regulation 199/23 Exemption - Restricted Titles, which now allows

		inter-jurisdictional Respiratory Therapists meeting specified conditions to work before registration with the CRTO. Although the policy has been updated to reflect these legislative changes, it's important to note that the intent and direction of the original policy remain unchanged. As such, the CRTO does not anticipate any associated risks with this revised policy.
New or consolidated class of certificates or licenses	Yes	In 2023, the Registration Regulation was amended to include the new Emergency Certificates of Registration RT(E). In response to this change, the CRTO developed a new webpage and updated several policy documents, including the Emergency Registration Policy and the Registration and Use of Title Professional Practice Guideline. Applications to the Emergency Class will be open when the CRTO Council or the government determines that there is an emergency, and it is in the public interest to register applicants in the Emergency Class. Additionally, the CRTO drafted CRTO's By-Law revisions to include the renewal and fee structure of the Emergency Registration Class (these By-law revisions were approved in March 2024).
Assessment of qualifications, including competency-based assessments and examinations	No	
Documentation requirements for registration	Yes	In 2023, the CRTO drafted a new Vulnerable Sector Checks policy. The policy was approved in March 2024 and will come into effect on September 1, 2024. Applicants will be required

		to submit the result of the VSC to the CRTO as
		part of their application. This policy applies to all applicants seeking registration with the CRTO, including those applying for initial registration and those applying for reinstatement (e.g., from suspension, resignation, or revocation). Although the policy was drafted in 2023, it will not be implemented until September 2024. Therefore, there has been no impact on applicants for the reported year. The CRTO anticipates that once implemented, this requirement will potentially impact applicants as there will be an additional cost to obtain the VSC report, and there may be some delays due to the processing timelines. To ensure that applicants are aware of the new requirements, CRTO staff will communicate these changes via the CRTO's website, application guides have also been updated to communicate this change. Additionally, CRTO Staff will visit RT schools in Ontario to communicate the requirements for registering with the CRTO.
Timelines for registration, decisions and/or responses	Yes	In 2023, the CRTO developed a set of Key Performance Indicators (KPIs), which include indicators from the Registration Program. The Registration KPIs were developed to measure the efficiency and efficacy of the CRTO's registration program in providing applicants with written acknowledgments of receipt of applications, communicating any missing documents, and issuing registration decisions. According to the quarterly KPI reports, the CRTO consistently meets the registration requirements outlined in the Registration Requirements Regulation (O. Reg. 508/22). Typically, staff respond to applications within 1-2 business days. Moreover, the average

		turnaround time for a Registrar to make a registration decision (e.g., approve a completed application or refer it to a Panel of the Registration Committee) is within five business days.
Registration and/or assessment fees	Yes	No fee changes have been implemented during the reporting year. However, in 2023, the Council approved the following for the 2024/25 registration year (effective March 1, 2024): the Registration fee increase from \$650 to \$700; the Clinical Skills Assessment fee increase from \$4,250 to \$5,000; and the Emergency Certificate of Registration – registration fees set at \$350. For a breakdown of the registration-related fees, please visit the Schedule of Fees: https://www.crto.on.ca/members/schedule-offees/. For the 2024 year, the CRTO increased the registration fee from \$650 to \$700. In addition, the CRTO included the Emergency Certificate Registration Fee. For applicants applying to the emergency class (when an emergency is declared by the CRTO's Council), there is a set fee of \$350 to issue an Emergency Certificate, and the renewal fee for the Emergency Certificate is \$350. The clinical skills assessment fee for internationally educated healthcare professionals (IEHPs) has been updated from \$4,250 to \$5,000. This new fee will apply to IEHPs applying to the CRTO from March 1, 2024. The increase in the fee is a result of the rise in fees charged by the simulation facility for conducting the clinical skills assessment. The average cost per candidate to run a single clinical skills assessment is slightly over \$5,000, meaning the CRTO has been incurring a loss per assessment. To offset these costs, the CRTO's Council passed a motion in December 2023 to

		increase the fee to \$5,000. The CRTO acknowledges that this fee increase does impact IEHP applicants and may add additional financial barriers to applicants. To address these concerns, the CRTO is exploring alternative facilities to potentially host the clinical skills assessment.

Training and resources for staff who deal with registration issues	Yes	The CRTO's legal counsel provides an annual training session for the Registration Committee and Registration staff. The training session covers various important topics, including decision-making processes, assessing qualifications, and making registration and review decisions. It also addresses any special considerations that may arise during the assessment of applicants and explains the procedures for applying those considerations. Additionally, the session delves into issues related to human rights, anti-discrimination, and providing accommodation for accessibility. Furthermore, the training emphasizes the CRTO's duty to provide transparent, objective, impartial, and fair registration practices.
Resources or training to support	Yes	Within the CRTO's website, an "Applicants" tab is dedicated to providing resources for

applicants to move through the licensing process		applicants. Navigating through this section allows applicants to easily access and review the registration requirements. They can select from different sections tailored to their circumstances, such as applicants from Canadian RT programs, other Canadian jurisdictions, or those educated outside of Canada. Each section provides background information and step-by-step outlines of the application process. Additionally, relevant links on the right-hand side of each webpage offer further resources to guide applicants through the licensing process, including application guides, assessment guides, various registration-related policies, verification forms, and fact sheets. To ensure currency and accuracy, registration-related webpages undergo continuous review and updating to align with current practices. For example, in 2023, the CRTO added the Emergency Class webpage to provide information about the new Class of Registration. In addition to the online resources, applicants can also contact the CRTO via email or through the "Contact Us" form available on the website. In addition to the information available on the CRTO's website, registration staff typically respond to inquiries within 1-2 business days. Additionally, internationally educated applicants have the opportunity to meet one-on-one with CRTO staff after completing each stage of the assessment process. Furthermore, a comprehensive two-step orientation to the Clinical Skills Assessment is provided to ensure applicants understand the assessment process thoroughly.

Mutual recognition agreements	Yes	In addition to our internationally educated healthcare professional applicants, the CRTO conducts the entry-to-practice assessment for applicants referred by other Canadian jurisdictions. In 2023, the CRTO established a Memorandum of Understanding (MOU) between itself and the other regulated Canadian Respiratory Therapy (RT) jurisdictions to identify the roles and responsibilities of each party as they relate to the CRTO's IEHP Entry to Practice (ETP) Competency Assessment.

D. Responsiveness to changes in the regulatory environment

Registration process	Changes Made (Yes / No)	Description
Emergency registration plans	Yes	In 2022, in an effort to strengthen Ontario's health human resource capacity, the government introduced a new regulation under the Regulated Health Professions Act, 1991 which requires that health regulatory Colleges, including the CRTO, have an Emergency Class of Registration. Per the requirement, the CRTO amended its Ontario Regulation 596/94, PART VIII Registration to include the Emergency Class. In addition, Part VII Prescribed Procedures and Part VII.1 Prescribed Substances were also amended to ensure that members registered in the Emergency Class can provide the necessary patient care. Similarly, the Controlled Acts Regulation has been amended to allow a member who holds an Emergency Certificate to perform tracheostomy tube changes and diagnostic ultrasound. With respect to the addition to the Emergency Class of Registration, the CRTO drafted amendments to its By-Laws to include fees associated with the Emergency Certificate of Registration. The following policies were also updated to align with the new Emergency Class: - Emergency Registration Policy (approved by Council on December 1, 2023) Graduate Certificate of Registration Policy (updated by the Registration Committee on November 14, 2023).
Technological or digital improvements	Yes	For the reported year, there were no technological changes related to registration. However, the CRTO is currently collaborating with a program developer to create a new database for handling membership data, along

		with developing a new application portal and redesigning the website. The goal of the new database is to enhance efficiency in managing applications and streamline the processing of registration fees.

		Alliance of Respiratory Therapy Regulatory Bodies (NARTRB) have collaboratively worked over the years to harmonize their registration practices, aiming to facilitate effective and efficient labour mobility of Respiratory Therapists (RTs) across Canada. Currently, the NARTRB is establishing national Standards of Practice for all RTs throughout Canada. When drafting the changes to its Registration Regulation the CRTO conducted a comprehensive national jurisdictional review. The objective was to align its practices as closely as possible with those of other provinces where Respiratory Therapy is regulated. This review encompassed evaluating the currency and suitability requirements for practice set by all other Canadian RT regulators, as well as their minimum practice hours requirements and maximum number of exam attempts.

For question B10, a panel of the Registration Committee (RC) reviewed a total of 14 files. Among these, 9 applications were initially from individuals educated in Ontario, and 1 applicant was educated in B.C. Out of the 9 applications from Ontario, one appeal to HPARB was received, and the result of the HPARB is still pending. Additionally, the panel reviewed 4 applications from internationally educated healthcare professionals (IEHPs) who completed the CRTO's entry-to-practice assessment process. In all 4 files, the Registration Committee decided to issue a Graduate Certificate of Registration with terms, conditions, and limitations

after the applicants complete a remediation plan. For question B.11, the CRTO received one appeal to HPARB during the reported year. The appeal is from a graduate of an approved RT program in Ontario. They requested all the terms, conditions, and limitations (TCLs) on their certificate of registration to be lifted. The TCLs were applied due to a prior decision made by a panel of the RC. This file has not been concluded, and the results of HPARB are still pending. Additionally, during the reporting year, the CRTO received an HPARB decision regarding an appeal filed in 2021. The HPARB decision confirmed the Registration Committee's decision for the Registrar to refuse to issue the applicant a certificate of registration (Bugarin v College of Respiratory Therapists of Ontario, 2023).

8. Changes Related to New Legislative and Regulatory Requirements

By Ontario law, regulated occupations must provide registration practices that are transparent, objective, impartial and far. Non-health occupations are governed by the *Fair Access to Regulated Professions and Compulsory Trades Act, 2006 (FARPACTA)*, while health professions are governed by *the Regulated Health Professions Act, 2011 (RHPA)*.

In 2021, both statutes were amended to incorporate substantive provisions to:

- **A.** Eliminate the use of Canadian experience requirements except under prescribed circumstances.
- **B.** Streamline language proficiency testing requirements.
- **C.** Provide for the continuity of registration processes during emergency situations.
- **D.** Set registration time limits. (FARPACTA only)

College of RESPIRATORY THERAPISTS of Ontario has made the following changes to comply with these new legal obligations:

A. Canadian Experience

Change required: No changes required

College of RESPIRATORY THERAPISTS of Ontario has taken the following measures to comply with legislative requirements on eliminating Canadian experience requirements unless an exemption is granted or an alternative is identified that meets criteria prescribed in regulations (non-health regulators) or the exceptions in legislation are met (regulated health colleges).

The CRTO does not require applicants for registration to have Canadian RT experience.

B. Language Proficiency Testing

Change required: Yes

College of RESPIRATORY THERAPISTS of Ontario has taken the following measures to comply with recent legislative changes requiring that regulators accept language proficiency testing results derived from any of the tests accepted for immigration purposes to satisfy their language proficiency requirements:

The CRTO's current language proficiency requirements are detailed in the Language Proficiency Requirements Policy (https://www.crto.on.ca/pdf/Policies/Policy.RG-407.pdf). The CRTO updated the policy in December 2022 to ensure alignment with new legislative requirements. In 2024, the CRTO enlisted a consultant to review the policy and provide recommendations, specifically regarding the inclusion of the Pearson Test of English (PTE) Core as part of the tests accepted by the CRTO. The revised Language Proficiency Requirements Policy was reviewed by the Registration Committee in May 2024 and subsequently approved by the Council during the June 2024 meeting.

C. Emergency Registration

College of RESPIRATORY THERAPISTS of Ontario has taken the following measures to comply with requirements to establish an emergency class (health colleges) or develop an emergency registration plan (non-health regulators).

The CRTO has made significant revisions to its Registration Regulation, notably incorporating the emergency class. The By-Laws and the Registration Use of Title Professional Practice Guideline were also revised to align with the addition of the Emergency Class of Registration. The By-Laws and the Registration and Use of Title Professional Practice Guideline received final approval by the Council in March 2024. Glossary of terms

Applicant: An individual who has applied for membership in a regulated profession or compulsory trade, with the associated rights to practice their profession / trade or use a professional title.

Domestic labour mobility: Applications subject to the Canadian Free Trade Agreement, which stipulates that a certificate issued by one province or territory should be recognized by all others unless there is an exception due to public health, safety and security reasons.

Internationally educated / trained: An individual whose initial professional education was not from a Canadian educational institution, or who is applying for trade certification based on experience gained outside Canada. This category includes individuals with education / training in the US and other countries. It also includes individuals who completed their initial professional education outside Canada and later addressed gaps with courses or a bridging program based in Canada.

Jurisdiction of initial training: For professions, the jurisdiction in which an applicant obtained their initial professional education used in full or partial fulfilment of registration requirements. For trades, the jurisdiction of initial trade experience listed on a Trades Equivalency Assessment (TEA) application.

Member: An individual who has satisfied the conditions for registration in their profession / trade and has been granted the right to practice and/or the right to use a professional designation or title. Members may hold a full license to engage in independent practice, or they may hold an alternate class of registration.

Racial identity: Voluntary self-report data of racial identity as a social description. Follows categories identified in the Ontario Anti-Racism Directorate Data https://www.ontario.ca/document/data-standards-identification-and-monitoring-systemic-racism.

Registration requirements: the entry-to-practice requirements that that an applicant must meet to be granted full membership in a regulated profession or trade, with the associated right to practice or right to use a professional title.

- **Academic requirement**: The formal education, or equivalent, that is required for licensing or certification in a particular regulated profession or trade.
- **Experience requirement:** The experiential training or work experience that is required for licensing or certification in a particular regulated profession or trade.
- **Language requirement**: The level of language proficiency that is required for licensing or certification in a particular regulated profession or trade, and the language proficiency tests accepted in fulfillment of this requirement.

Third party service provider: An external organization that assesses applicant qualifications on behalf of the regulator.
